1. That, in oder to effectuate his aforesaid desire, the President has set apart and handed over to the trustees, a sum of Rs. 25,000 Twenty Five Thousand (hereinafter called the Trust Fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part there of might be converted invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or wtherwise howsoever in relation to these presents, and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained. That the name of the trust shall be "DELHI PUBLIC SCHOOL EDUCATIONAL TRUST" (BIHAR CHAPTER) and office will be situated at Bahadurpur, Ward No.- 26, Distt. - Samastipur, Pin
