

## AFFIDAVIT

### **REGARDING CHANGE OF NAME OF SCHOOL, UNDERTAKING OF DISTINCT IDENTITY, AND DECLARATION OF ABSENCE OF MISREPRESENTATION**

I, Masood Hasan, son of Late Shri Mansoor Hasan, aged about 51 years, resident of Boring Road, Ward No. 19, Tajpur, District Samastipur, Bihar, PIN – 848130, Aadhaar No. 732504006131, presently serving as Chairman and Authorized Signatory of the school/institution which had earlier applied before the Central Board of Secondary Education under the name Delhi Public School Tajpur, do hereby solemnly affirm, state and declare on oath as follows:

1. That I am the Chairman and Authorized Signatory of the institution concerned and, being duly authorized by the management, am fully competent to swear and execute the present Affidavit on behalf of the school/institution.
2. That the institution had applied for grant of affiliation before the Central Board of Secondary Education under the name Delhi Public School Tajpur.
3. That the said application was processed by the competent authorities of CBSE; however, affiliation was not granted and the case came to be rejected on account of the issue concerning the name of the school.
4. That, thereafter, with a view to removing any objection, ambiguity, or possible confusion arising from the earlier name of the institution, and in order to establish and maintain a separate, distinct, and non-misleading institutional identity, the management has initiated and undertaken the process for change of the name of the school.
5. That the institution has now proposed and adopted the name:  
Delhi International Public School Tajpur (DIPST) and the said name is intended to be the official and distinct name of the institution, subject to such updation, endorsement, approval, and incorporation as may be required in the relevant statutory, regulatory, administrative, and institutional records.
6. That the institution is independently managed and administered and is not affiliated with, associated with, sponsored by, controlled by, recognized as a branch of, franchise of, extension of, unit of, or sister concern of Delhi Public School Society or any other similarly named institution, organization, chain, or group, save and except as may be expressly disclosed in official records, if any.
7. That the institution neither uses nor proposes to use the acronym "DPS" as its institutional abbreviation, short form, or identifying mark, and shall maintain its separate, independent, and distinguishable identity under the name Delhi International Public School Tajpur (DIPST).
8. That the adoption of the changed name has been made bona fide, in good faith, and solely for the purpose of ensuring a clear, independent, and legally distinguishable identity of the institution, and not with any intent to derive benefit from, imitate, resemble, or misrepresent any other institution, society, chain, or educational body.
9. That no false representation, claim, or assertion of affiliation, sponsorship, ownership, control, approval, authorization, recognition, franchise, association, or institutional linkage with Delhi Public School Society or

with any other school society, educational trust, chain, or group has been made by the institution at any point of time, nor shall any such false representation, claim, or assertion be made in future.

10. That upon completion of the formal process of name change and corresponding updation in the concerned records, documents, permissions, certificates, and approvals, the earlier name, namely Delhi Public School Tajpur, shall not thereafter be used as the official name of the institution.

10A. That wherever the earlier name Delhi Public School Tajpur appears in prior applications, correspondence, inspection records, submissions, papers, communications, or other historical documents, the same may kindly be construed and read as referring to the very same institution, which is now proposed to continue under the changed name Delhi International Public School Tajpur (DIPST), there being no change in the identity of the management except the change in the name of the institution.

11. That the institution undertakes to update, align, regularize, and maintain all relevant records and documents in conformity with the changed name, as and when required and as may be applicable, including but not limited to land-related records, fire safety records, recognition-related records, No Objection Certificate records, institutional documents, and all other statutory, regulatory, or administrative papers.

12. That the change of name does not alter or affect the bona fide educational purpose, physical campus, continuity of management, or lawful functioning of the institution, except to the limited extent of adopting a new and distinct official name.

13. That the present Affidavit is being sworn and executed in support of the request that the institution be considered under the changed/proposed name Delhi International Public School Tajpur (DIPST), and that the matter be fairly, reasonably, and sympathetically reconsidered by the competent authorities, including the Central Board of Secondary Education.

14. That this Affidavit is also being submitted to place on record the bona fide conduct of the institution, the absence of any intention to mislead or misrepresent, and the undertaking of the management to maintain a separate and clearly distinguishable institutional identity.

15. That the statements made hereinabove are true and correct to my knowledge and belief, and that nothing material has been concealed therefrom.

**After detailed discussion and due consideration, the following resolution was unanimously passed:**







Further, the committee acknowledged the resolution passed by the Delhi Public School Education Trust (Bihar Chapter) dated 02.03.2026 approving the change of name of the institution.

"RESOLVED THAT" the School Management Committee hereby formally acknowledges the rejection of the CBSE affiliation application and accepts the observations raised by the Board.

"RESOLVED FURTHER THAT" in compliance with CBSE guidelines and to resolve the issue of name/trademark conflict, the name of the school be changed from:

Delhi Public School Jaipur to  
Delhi International Public School Jaipur (DIPST)

The change shall be implemented for all official, academic and administrative purposes "from the upcoming academic session"

"RESOLVED FURTHER THAT" the school shall undertake complete transition of all records and documents to the new name, including but limited to:

- a) School records and affiliation records
- b) CBSE application and affiliation records
- c) Bank accounts and financial documents

d) Signage, letterheads, website and communication materials

e) Staff records and student-related documents

"RESOLVED FURTHER THAT" the school Management Committee authorizes the Head of the Institution and the Trust to take all necessary steps to:

1. Apply for "NOC (No objection Certificate) under the new name.
2. Obtain "Recognition Certificate" from the competent authority.
3. Update all statutory and regulatory approvals
4. Complete all documentation required under CBSE Affiliation Bye-Laws.

"RESOLVED FURTHER THAT" the school shall submit a Review Application against the rejection within the stipulated timeline on the SARAS portal, along with compliance and corrective measures undertaken.

The committee emphasized that all actions must be executed in a time-bound, legally compliant and fully documented manner to ensure successful affiliation in the next cycle.
