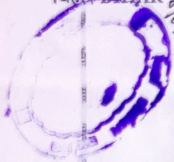

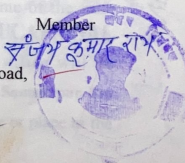

And whereas if the Trustees desire to co-opt another eminent personalities as trustees for betterment of trust, they can co-opt.

And whereas if any vacancy made in Board of trustees these vacancy can be fulfilled by Co-option.

Whereas the President is desirous of establishing a trust for public charitable objects.

And whereas the Trustees have at the request of the President, agreed to act as the first trustees of these presents as testified their being parties to and executing these presents.

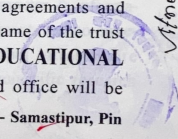
And whereas it is necessary to declare the aims and objects of the public charitable public Trust, being constituted under these presents.

Now this indenture witnesseth as follows :-

1. That, in order to effectuate his aforesaid desire, the President has set apart and handed over to the trustees, a sum of Rs. 25,000 Twenty Five Thousand (hereinafter called the Trust Fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part there of might be converted invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents, and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained. That the name of the trust shall be "**DELHI PUBLIC SCHOOL EDUCATIONAL TRUST**" (BIHAR CHAPTER) and office will be situated at **Bahadurpur, Ward No.- 26, Distt. - Samastipur, Pin Code- 848101 (Bihar)** and/or at such other place or place as the

- (d) Conduct the programmes to ensure nutrition-security safe food processing and standarderdication

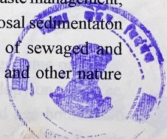

(xiii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(xiv) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiation with the Government Departments, public and other bodies and corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.

(xv) To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.

(xvi) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in may be thought expedient.

(xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

(xviii) To take land/property on lease and then after sublease the land property to the farmers and other organizations like

10. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.

11. Full Time working Trustees will be entitled to and also reasonable honorarium as decided may re- reimburse themselves of all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

12. All decisions will be based on majority opinion which will include the chairman, Secretary, Treasurer.

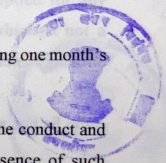
13. A person shall cease to be a Trustee either :-

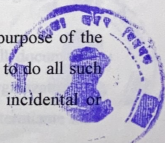

21. **POWER & FUNCTION OF THE OFFICE BEARER PRESIDENT :**

The President shall preside over at all meetings of the trust, when he is present and shall exercise such other powers as are conferred upon him by these rules the President may call for an emergency meeting through President signed notice in a shorter period. The decision of President that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a vote is demand, on voting demande, the same shall be taken in such manner as the President may in discretion determine. - e) He/She will be responsible to general body in all



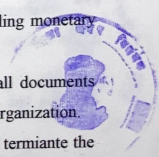
matters. He/She will contract in all ways and means of the position of the association and shall have right to improve it.
